Below are the official rules and regulations for candidacy in the election of Officers for the International Congress. If you choose to nominate a qualified person or to re-nominate a current International Congress Officer, please complete the nomination form. ***THERE WILL BE NO NOMINATION FROM THE FLOOR.*** All nominees must meet the following criteria:

GENERAL OFFICER PRE-REQUISITS:

No nominee will be considered for office without the approval from his or her pastor or assistant pastor. Current International Congress Officers must submit notification of his or her intent to run for re-election. All applicants must:

- Have the experience of Acts 2:4, 38
- Be a member of a church within the Church of Our Lord Jesus Christ
- Be actively involved in Sunday School and/or ABYPU activities at the local/state/diocese level
- Have demonstrated that ability to lead in the area that you are being nominated

PRESIDENTIAL PRE-REQUISITS:

Moreover the office of President must have administrative experience to include:

- Innovative program coordination abilities
- Knowledge of the International Congress, Sunday School and ABYPU laws
- Strong oral and written skills

“ARTICLE IV”

In accordance with the International Congress constitution, Article IV, Term of Office, “...Each officer may continue in office if re-elected.” In 2004, Article IV was amended so that no officer could serve more than two three-year terms. Article IV has been amended by Executive Order, so that Article IV now has become retroactive to 2001 Elections. Persons who already have served two terms are no longer eligible for re-election this 2010-2013 election term.
